## Guide for Citing Resources: Chicago Manual of Style (Author-Date System)

This guide is based on *The Chicago Manual of Style 15th ed.* (University of Chicago Press, 2003). Examples are shown for the newer Author-Date system recommended for the **Physical, Natural and Social Sciences**.

**Reference list** items are listed alphabetically at the end of the research paper. **In-Text** citations are noted in the body of the paper.

Numbers in brackets [ ] refer to the section of the *Chicago Manual of Style* which describes the specific citation style. Consult these pages for more information.
